
Property Sales



Inventory & MSI

The Total Inventory of Properties available for sale as of June was 614, down -11.9% from 697 last month and down -15.3% from 725 in June of last year. June 2016 Inventory was at the lowest level compared to June of 2015 and 2014.

A comparatively lower MSI is more beneficial for sellers while a higher MSI is better for buyers. The June 2016 MSI of 6.0 months was at its lowest level compared with June of 2015 and 2014.


MSI is the # of months needed to sell all of the Inventory at the monthly Sales Pace



Market Time

The average Days On Market(DOM) shows how many days the average Property is on the Market before it sells. An upward trend in DOM tends to indicate a move towards more of a Buyer's market, a downward trend a move towards more of a Seller's market. The DOM for June was 132, down -21.0% from 167 days last month and up 6.5% from 124 days in June of last year. The June 2016 DOM was at a mid range compared with June of 2015 and 2014.


Average Days on Market(Listing to Contract) for properties sold during the month



Selling Price per Square Foot

The Selling Price per Square Foot is a great indicator for the direction of Property values. Since Median Sales Price and Average Sales price can be impacted by the 'mix' of high or low end Properties in the market, the selling price per square foot is a more normalized indicator on the direction of Property values. The June 2016 Selling Price per Square Foot of \$284 was down -8.1% from \$309 last month and down -10.4% from \$317 in June of last year.



Selling Price vs Listing Price



The lower the ratio is below 100% the more of a Buyer's market exists, a ratio at or above 100% indicates more of a Seller's market. The June 2016 Selling Price vs List Price of 96.2% was down from 97.8% last month and down from 97.7% in June of last year.
