
Property Sales

October Property sales were 4, down -33.3% from 6 in October of 2015 and -33.3% lower than the 6 sales last month. October 2016 sales were at a mid level compared to October of 2015 and 2014. October YTD sales of 53 are running -8.6% behind last year's year-to-date sales of 58.



The Median Sales Price in October was \$907,500, up 11.2% from \$816,000 in October of 2015 and up 21.4% from \$747,500 last month. The Average Sales Price in October was \$1,075,500, up 14.8% from \$936,917 in October of 2015 and up 44.2% from \$746,083 last month. October 2016 ASP was at highest level compared to October of 2015 and 2014.

Inventory & MSI

The Total Inventory of Properties available for sale as of October was 64, down -4.5% from 67 last month and down -19.0% from 79 in October of last year. October 2016 Inventory was at a mid range compared to October of 2015 and 2014.

A comparatively lower MSI is more beneficial for sellers while a higher MSI is better for buyers. The October 2016 MSI of 16.0 months was at a mid range compared with October of 2015 and 2014.

MSI is the # of months needed to sell all of the Inventory at the monthly Sales Pace



Market Time

The average Days On Market(DOM) shows how many days the average Property is on the Market before it sells. An upward trend in DOM tends to indicate a move towards more of a Buyer's market, a downward trend a move towards more of a Seller's market. The DOM for October was 100, down -2.9% from 103 days last month and down -27.0% from 137 days in October of last year. The October 2016 DOM was at its lowest level compared with October of 2015 and 2014.


Average Days on Market(Listing to Contract) for properties sold during the month



Selling Price per Square Foot

The Selling Price per Square Foot is a great indicator for the direction of Property values. Since Median Sales Price and Average Sales price can be impacted by the 'mix' of high or low end Properties in the market, the selling price per square foot is a more normalized indicator on the direction of Property values. The October 2016 Selling Price per Square Foot of \$335 was up 5.0% from \$319 last month and up 8.4% from \$309 in October of last year.



Selling Price vs Listing Price

The Selling Price vs Listing Price reveals the average amount that Sellers are agreeing to come down from their list price. The lower the ratio is below 100% the more of a Buyer's market exists, a ratio at or above 100% indicates more of a Seller's market. The October 2016 Selling Price vs List Price of 95.1% was up from 94.7% last month and down from 95.2% in October of last year.

Inventory / New Listings / Sales

This last view of the market combines monthly inventory of Properties for sale along with New Listings and Sales. The graph shows the basic annual seasonality of the market as well as the relationship between these items. The number of New Listings in October 2016 was 6, down -45.5% from 11 last month and down -40.0% from 10 in October of last year.
