
Property Sales

March Property sales were 26, up 44.4% from 18 in March of 2016 and 52.9% higher than the 17 sales last month. March 2017 sales were at a mid level compared to March of 2016 and 2015. March YTD sales of 67 are running 8.1% ahead of last year's year-to-date sales of 62.



The Median Sales Price in March was \$1,385,000, up 19.2% from \$1,161,500 in March of 2016 and down -18.8% from \$1,705,000 last month. The Average Sales Price in March was \$1,452,030, up 6.9% from \$1,358,847 in March of 2016 and down -22.1% from \$1,863,193 last month. March 2017 ASP was at a mid range compared to March of 2016 and 2015.



Inventory & MSI

The Total Inventory of Properties available for sale as of March was 381, up 6.7% from 357 last month and down -9.9% from 423 in March of last year. March 2017 Inventory was at a mid range compared to March of 2016 and 2015.


A comparatively lower MSI is more beneficial for sellers while a higher MSI is better for buyers. The March 2017 MSI of 14.7 months was at a mid range compared with March of 2016 and 2015.

MSI is the # of months needed to sell all of the Inventory at the monthly Sales Pace



The average Days On Market(DOM) shows how many days the average Property is on the Market before it sells. An upward trend in DOM tends to indicate a move towards more of a Buyer's market, a downward trend a move towards more of a Seller's market. The DOM for March was 141, down -19.9% from 176 days last month and down -14.0% from 164 days in March of last year. The March 2017 DOM was at its lowest level compared with March of 2016 and 2015.


Average Days on Market(Listing to Contract) for properties sold during the month



Selling Price per Square Foot

The Selling Price per Square Foot is a great indicator for the direction of Property values. Since Median Sales Price and Average Sales price can be impacted by the 'mix' of high or low end Properties in the market, the selling price per square foot is a more normalized indicator on the direction of Property values. The March 2017 Selling Price per Square Foot of \$390 was down -12.6% from \$446 last month and down -3.7% from \$405 in March of last year.



Selling Price vs Listing Price


The Selling Price vs Listing Price reveals the average amount that Sellers are agreeing to come down from their list price. The lower the ratio is below 100% the more of a Buyer's market exists, a ratio at or above 100% indicates more of a Seller's market. The March 2017 Selling Price vs List Price of 92.4% was down from 92.8% last month and up from 90.7% in March of last year.

Inventory / New Listings / Sales

'This last view of the market combines monthly inventory of Properties for sale along with New Listings and Sales. The graph shows the basic annual seasonality of the market as well as the relationship between these items.
