
Property Sales

October Property sales were 13, down -35.0% from 20 in October of 2014 and -23.5% lower than the 17 sales last month. October 2015 sales were at a mid level compared to October of 2014 and 2013. October YTD sales of 180 are running -10.4% behind last year's year-to-date sales of 201.



The Median Sales Price in October was \$617,000, down -6.7% from \$661,500 in October of 2014 and down -16.5% from \$739,000 last month. The Average Sales Price in October was \$812,662, up 12.8% from \$720,415 in October of 2014 and up 11.9% from \$726,138 last month. October 2015 ASP was at a mid range compared to October of 2014 and 2013.

Inventory & MSI

The Total Inventory of Properties available for sale as of October was 209, down -9.9% from 232 last month and up 19.4% from 175 in October of last year. October 2015 Inventory was at highest level compared to October of 2014 and 2013.

A comparatively lower MSI is more beneficial for sellers while a higher MSI is better for buyers. The October 2015 MSI of 16.1 months was at its highest level compared with October of 2014 and 2013.


MSI is the # of months needed to sell all of the Inventory at the monthly Sales Pace



Market Time

The average Days On Market(DOM) shows how many days the average Property is on the Market before it sells. An upward trend in DOM tends to indicate a move towards more of a Buyer's market, a downward trend a move towards more of a Seller's market. The DOM for October was 129, up 3.2% from 125 days last month and down -14.0% from 150 days in October of last year. The October 2015 DOM was at its lowest level compared with October of 2014 and 2013.


Average Days on Market(Listing to Contract) for properties sold during the month



Selling Price per Square Foot

The Selling Price per Square Foot is a great indicator for the direction of Property values. Since Median Sales Price and Average Sales price can be impacted by the 'mix' of high or low end Properties in the market, the selling price per square foot is a more normalized indicator on the direction of Property values. The October 2015 Selling Price per Square Foot of \$250 was down -12.9% from \$287 last month and down -9.1% from \$275 in October of last year.



Selling Price vs Listing Price


The Selling Price vs Listing Price reveals the average amount that Sellers are agreeing to come down from their list price. The lower the ratio is below 100% the more of a Buyer's market exists, a ratio at or above 100% indicates more of a Seller's market. The October 2015 Selling Price vs List Price of 96.0% was up from 95.6% last month and down from 96.5% in October of last year.

Inventory / New Listings / Sales

This last view of the market combines monthly inventory of Properties for sale along with New Listings and Sales. The graph shows the basic annual seasonality of the market as well as the relationship between these items. The number of New Listings in October 2015 was 29, down -25.6% from 39 last month and up 11.5% from 26 in October of last year.
