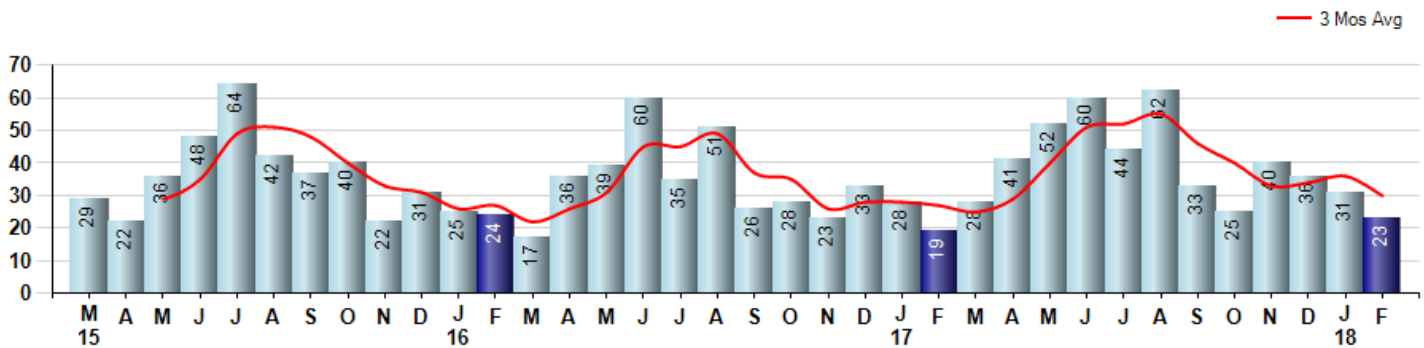

### Property Sales

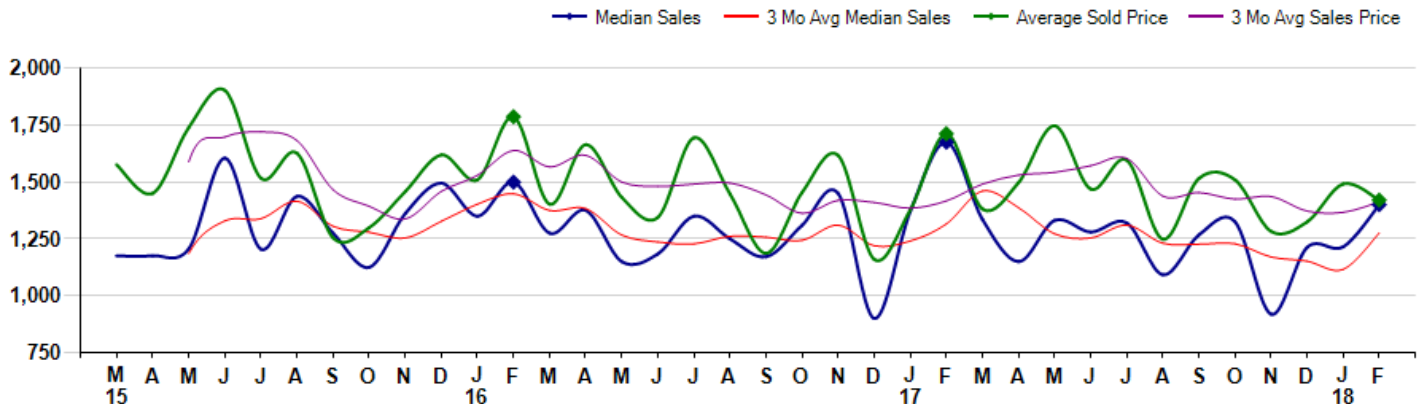
February Property sales were 23, up 21.1% from 19 in February of 2017 and -25.8% lower than the 31 sales last month. February 2018 sales were at a mid level compared to February of 2017 and 2016. February YTD sales of 54 are running 14.9% ahead of last year's year-to-date sales of 47.



### Prices

The Median Sales Price in February was \$1,400,000, down -16.4% from \$1,675,000 in February of 2017 and up 15.2% from \$1,215,000 last month. The Average Sales Price in February was \$1,420,241, down -17.1% from \$1,712,225 in February of 2017 and down -4.8% from \$1,491,719 last month. February 2018 ASP was at the lowest level compared to February of 2017 and 2016.

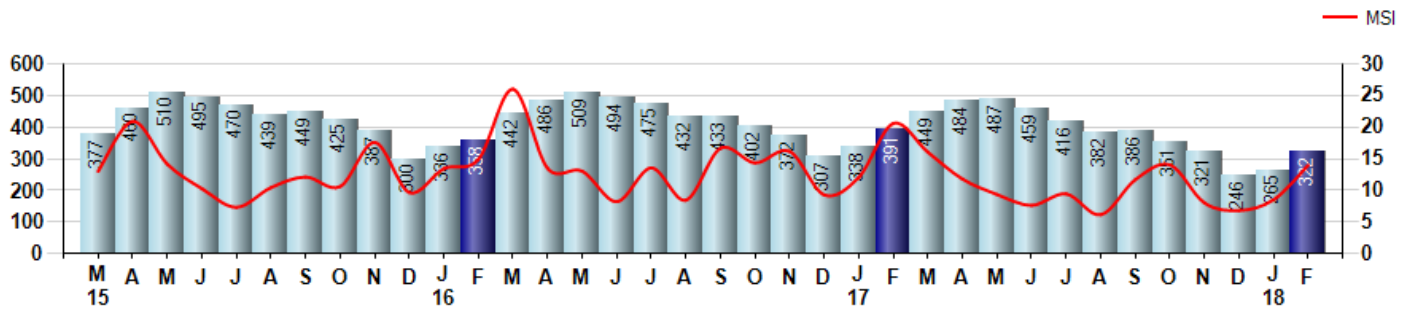

### Inventory & MSI

The Total Inventory of Properties available for sale as of February was 322, up 21.5% from 265 last month and down -17.6% from 391 in February of last year. February 2018 Inventory was at the lowest level compared to February of 2017 and 2016.

A comparatively lower MSI is more beneficial for sellers while a higher MSI is better for buyers. The February 2018 MSI of 14.0 months was at its lowest level compared with February of 2017 and 2016.

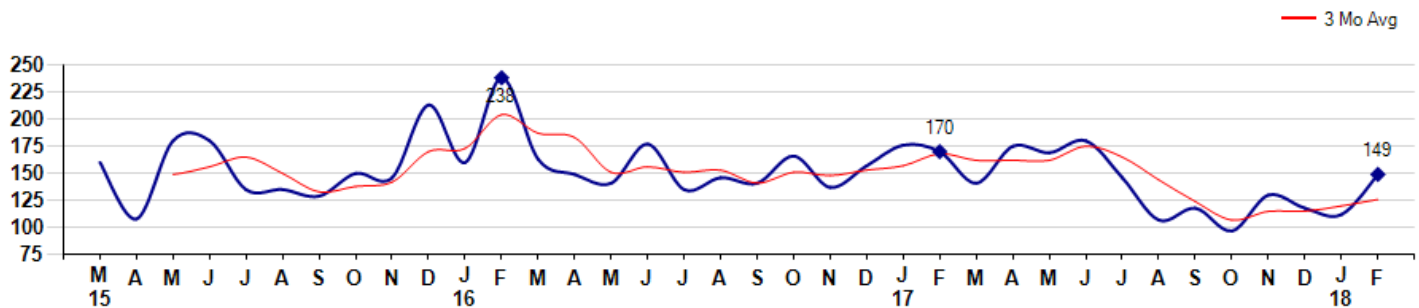
MSI is the # of months needed to sell all of the Inventory at the monthly Sales Pace



### Market Time

The average Days On Market(DOM) shows how many days the average Property is on the Market before it sells. An upward trend in DOM tends to indicate a move towards more of a Buyer's market, a downward trend a move towards more of a Seller's market. The DOM for February was 149, up 33.0% from 112 days last month and down -12.4% from 170 days in February of last year. The February 2018 DOM was at its lowest level compared with February of 2017 and 2016.

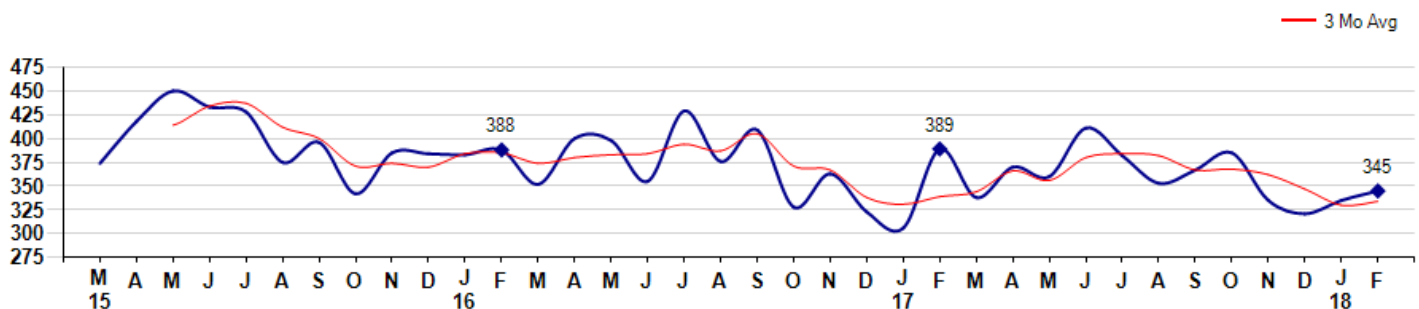
Average Days on Market(Listing to Contract) for properties sold during the month



### Selling Price per Square Foot

The Selling Price per Square Foot is a great indicator for the direction of Property values. Since Median Sales Price and Average Sales price can be impacted by the 'mix' of high or low end Properties in the market, the selling price per square foot is a more normalized indicator on the direction of Property values. The February 2018 Selling Price per Square Foot of \$345 was up 3.0% from \$335 last month and down -11.3% from \$389 in February of last year.

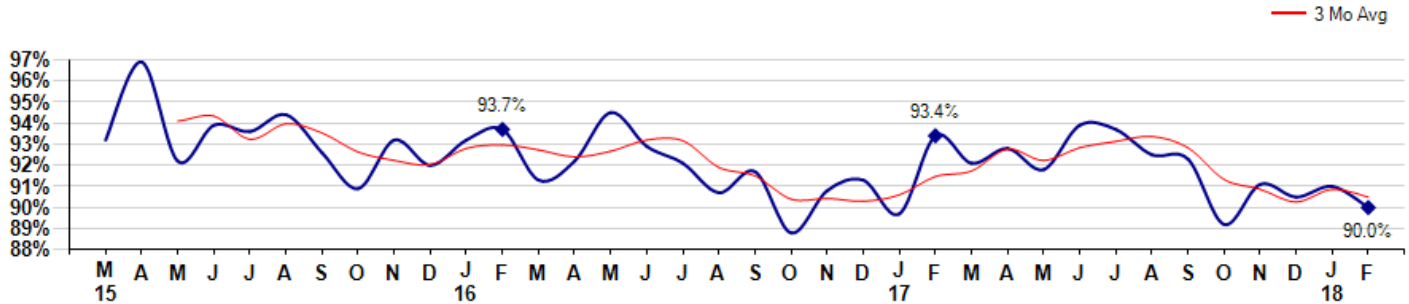

### Selling Price vs Listing Price

The Selling Price vs Listing Price reveals the average amount that Sellers are agreeing to come down from their list price. The lower the ratio is below 100% the more of a Buyer's market exists, a ratio at or above 100% indicates more of a Seller's market. The February 2018 Selling Price vs List Price of 90.0% was down from 91.0% last month and down from 93.4% in February of last year.

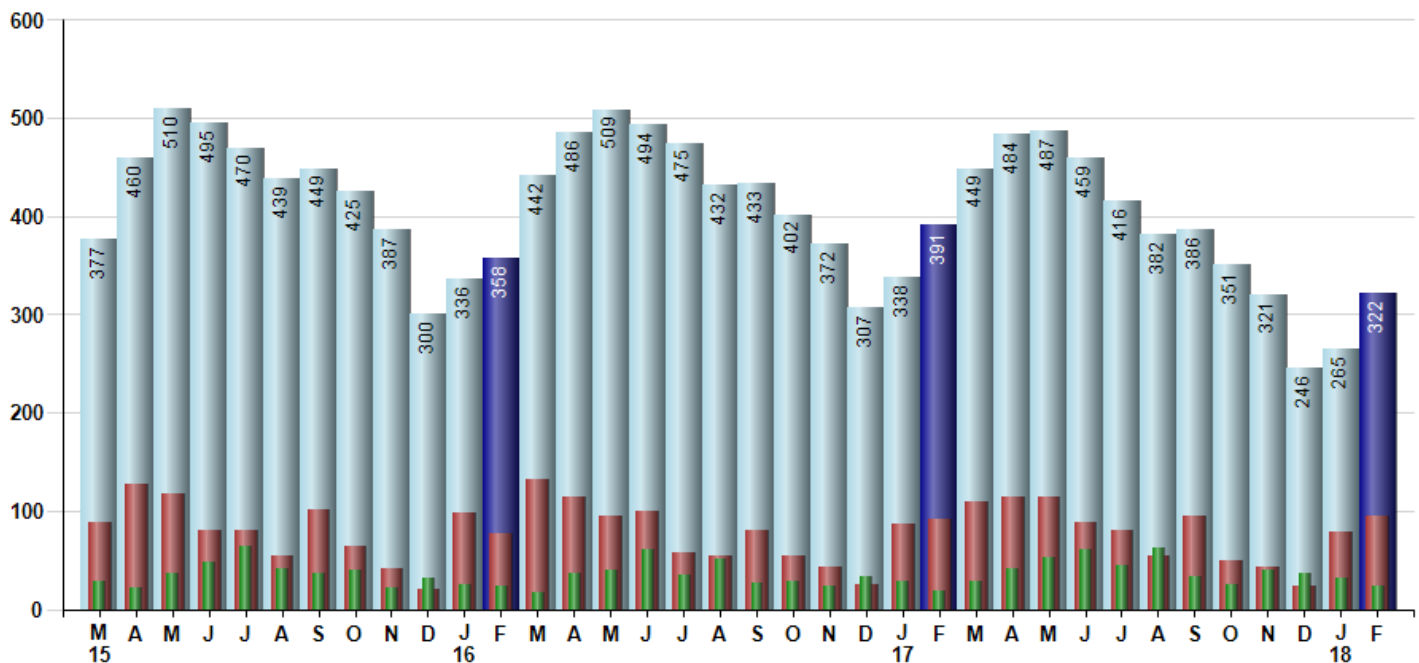
Avg Selling Price divided by Avg Listing Price for sold properties during the month



### Inventory / New Listings / Sales

This last view of the market combines monthly inventory of Properties for sale along with New Listings and Sales. The graph shows the basic annual seasonality of the market as well as the relationship between these items. The number of New Listings in February 2018 was 95, up 20.3% from 79 last month and up 4.4% from 91 in February of last year.
