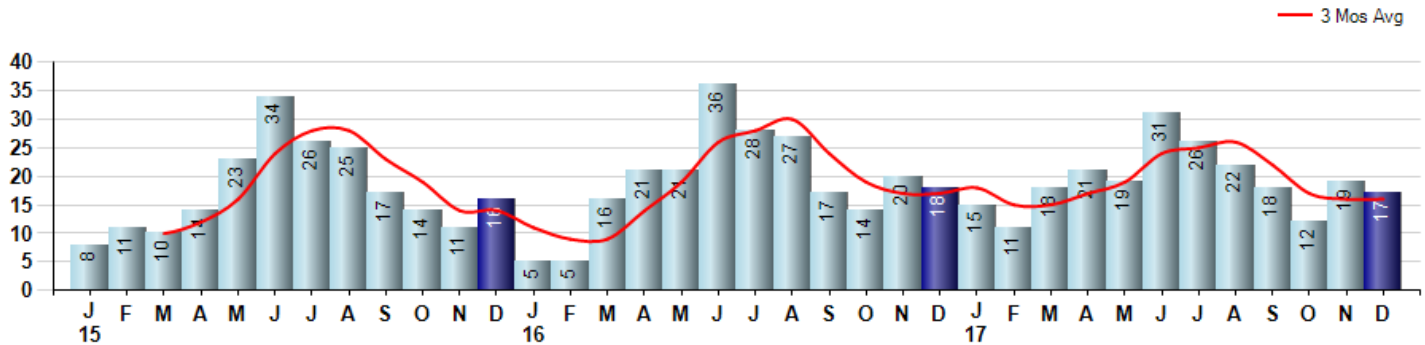

Property Sales

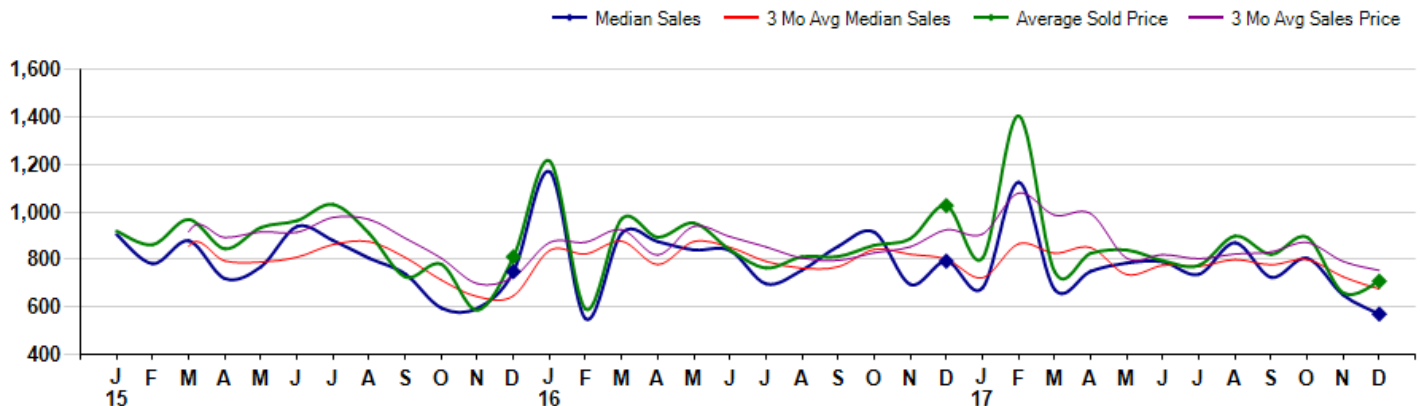
December Property sales were 17, down -5.6% from 18 in December of 2016 and -10.5% lower than the 19 sales last month. December 2017 sales were at a mid level compared to December of 2016 and 2015. December YTD sales of 229 are running 0.4% ahead of last year's year-to-date sales of 228.



Prices

The Median Sales Price in December was \$570,000, down -28.1% from \$792,500 in December of 2016 and down -12.3% from \$650,000 last month. The Average Sales Price in December was \$708,353, down -31.0% from \$1,026,667 in December of 2016 and up 7.4% from \$659,368 last month. December 2017 ASP was at the lowest level compared to December of 2016 and 2015.

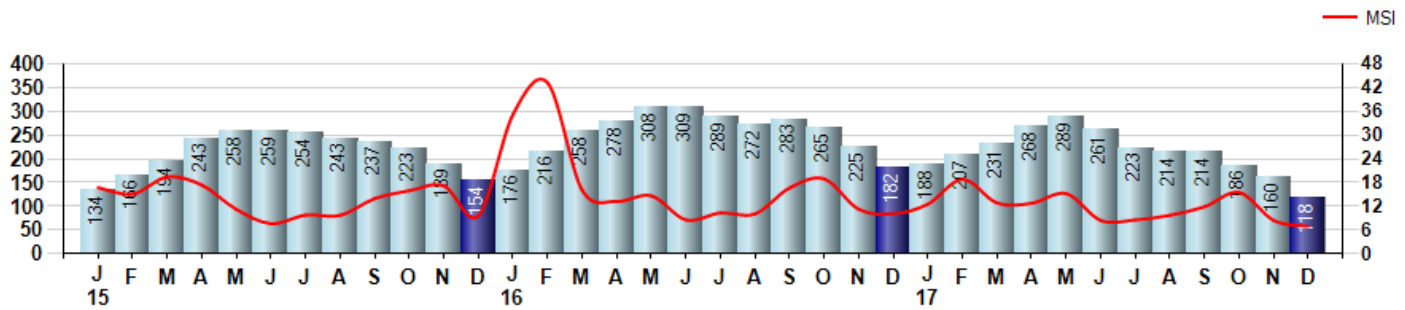

Inventory & MSI

The Total Inventory of Properties available for sale as of December was 118, down -26.3% from 160 last month and down -35.2% from 182 in December of last year. December 2017 Inventory was at the lowest level compared to December of 2016 and 2015.

A comparatively lower MSI is more beneficial for sellers while a higher MSI is better for buyers. The December 2017 MSI of 6.9 months was at its lowest level compared with December of 2016 and 2015.

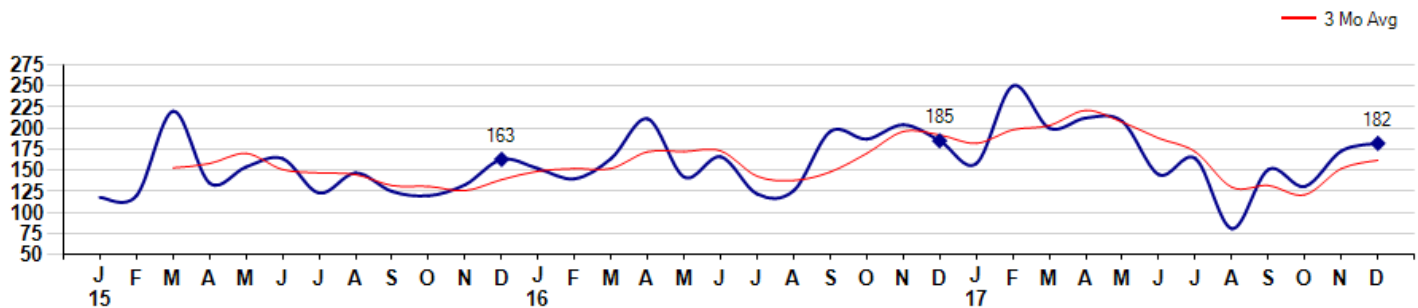
MSI is the # of months needed to sell all of the Inventory at the monthly Sales Pace



Market Time

The average Days On Market(DOM) shows how many days the average Property is on the Market before it sells. An upward trend in DOM tends to indicate a move towards more of a Buyer's market, a downward trend a move towards more of a Seller's market. The DOM for December was 182, up 5.2% from 173 days last month and down -1.6% from 185 days in December of last year. The December 2017 DOM was at a mid range compared with December of 2016 and 2015.

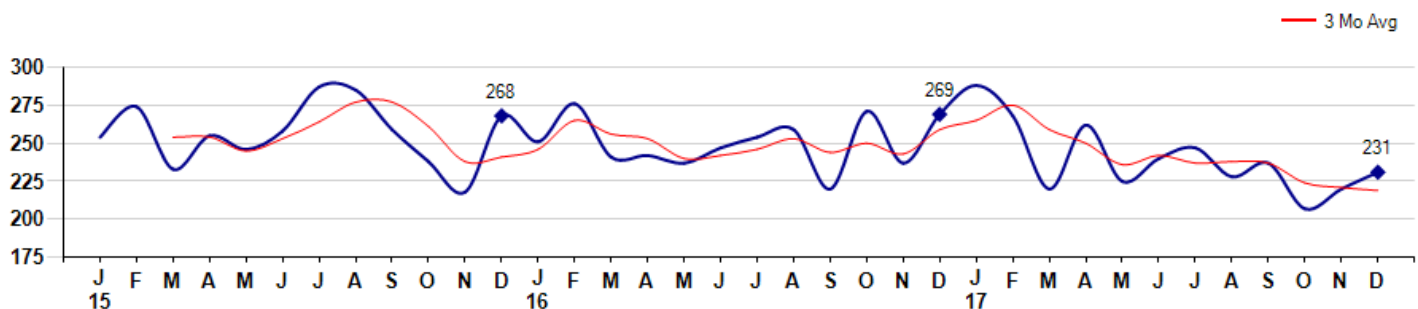
Average Days on Market(Listing to Contract) for properties sold during the month



Selling Price per Square Foot

The Selling Price per Square Foot is a great indicator for the direction of Property values. Since Median Sales Price and Average Sales price can be impacted by the 'mix' of high or low end Properties in the market, the selling price per square foot is a more normalized indicator on the direction of Property values. The December 2017 Selling Price per Square Foot of \$231 was up 5.0% from \$220 last month and down -14.1% from \$269 in December of last year.

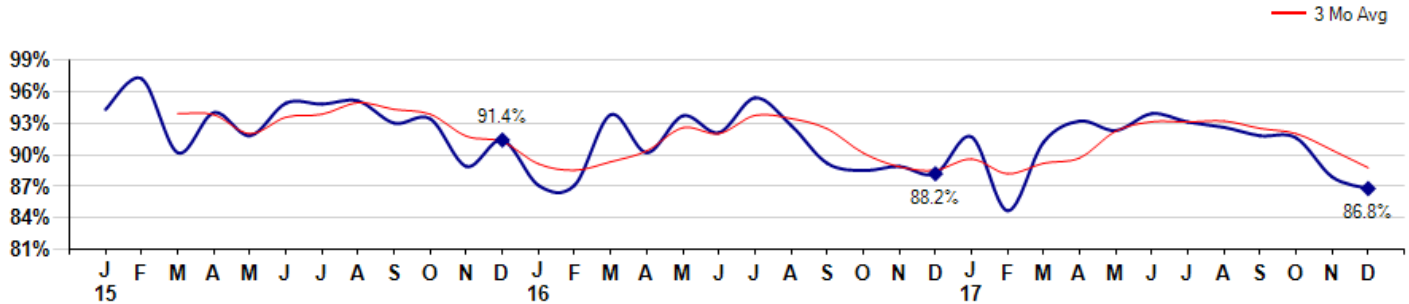

Selling Price vs Listing Price

The Selling Price vs Listing Price reveals the average amount that Sellers are agreeing to come down from their list price. The lower the ratio is below 100% the more of a Buyer's market exists, a ratio at or above 100% indicates more of a Seller's market. The December 2017 Selling Price vs List Price of 86.8% was down from 87.9% last month and down from 88.2% in December of last year.

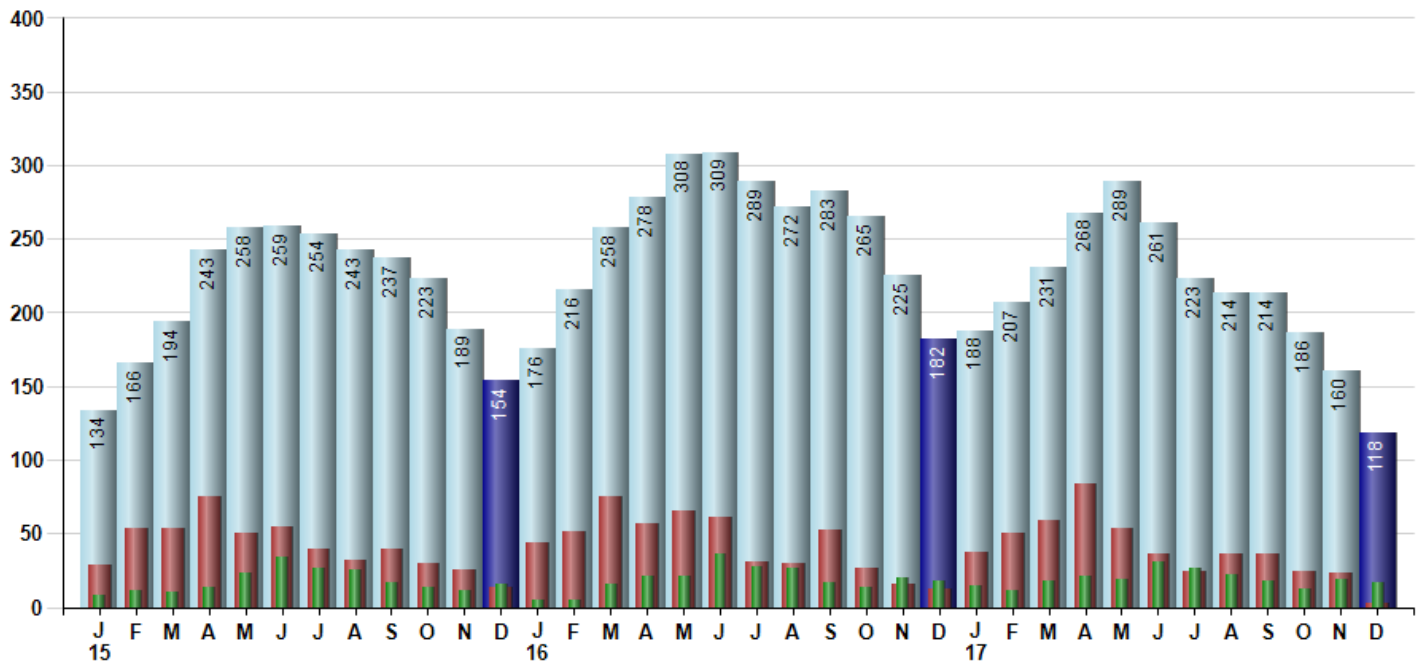
Avg Selling Price divided by Avg Listing Price for sold properties during the month



Inventory / New Listings / Sales

This last view of the market combines monthly inventory of Properties for sale along with New Listings and Sales. The graph shows the basic annual seasonality of the market as well as the relationship between these items. The number of New Listings in December 2017 was 3, down -87.0% from 23 last month and down -75.0% from 12 in December of last year.
